- c. Just Transition: The transition to net zero is not just essential; it is an opportunity for economic growth and job creation.
- d. Fostering Regional Cooperation: As ASEAN chair, we have a responsibility to collaborate. By leveraging our collective strengths and resources, we can amplify our voices and advocate for solutions that benefit the entire region.
- 6. Most importantly, success at COP29 is not merely a destination but the foundation for continued achievements at COP30 and beyond. The momentum we build now will define our trajectory in the global arena.
